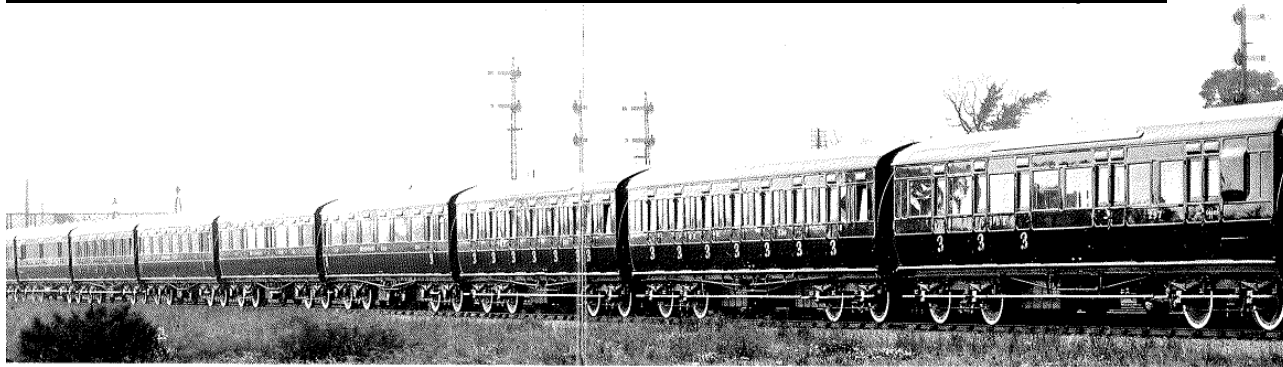


## GER Brake third BTK no 295 built 1907 for the Norfolk Coast Express



This coach was part of the Norfolk Coast Express the first modern style corridor train built for the Great Eastern for the crack Liverpool Street service to Sheringham, in 1907. The first all bogie set train built to make use of the running powers over the M&GN to Sheringham.

It survived in departmental traffic until purchased for preservation in 1967.

Now coming up to her fortieth year (Ruby) in preservation and her Centenarian year, the 295 club is being launched.

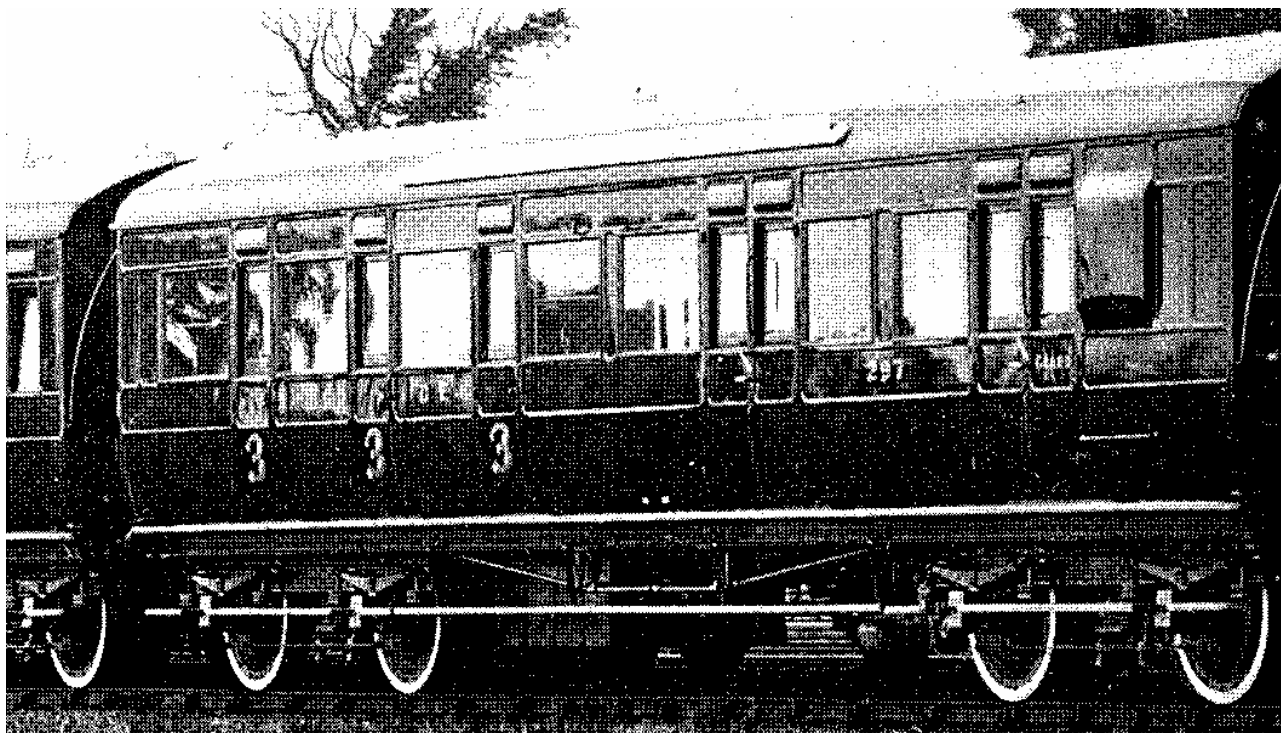
We need £2.95 or more! a month or single one off donations to enable a steady progress on restoration to take place.

The work required is extensive, the main body framing is badly wasted and all 14 doors need major repair work or replacement. New external panelling and toughened window glass, roof to be re canvassed. Three compartments will need new seats and the missing luggage sliding doors replaced. The compartment nearest the luggage area will be modified to allow wheel chair access into the compartment through the dividing wall so disabled users can experience compartment travel.

Stage one: the body will be separated from the frame and placed on the bogie bolster for safe keeping. The frame and bogies are in very bad condition after 100 years of rust, they will then be stripped down to their basic parts and grit blasted. A thorough inspection will then take place and repairs/ strengthening plates will be added as necessary. These will be painted and reassembled into a rolling chassis,

Stage two: the body will then be refitted and the body will then be repaired.
